



CONTEST RULES

Eligibility

This contest is available to all residents of Ontario who have reached the age of majority (18+) at the time of entry. Please note that Tamarack Home employees and their immediate family members are not eligible to participate in the contest.

How to Enter

NO PURCHASE NECESSARY. To enter the contest, each contestant must visit one of Tamarack Homes' Sales Offices to provide their name, email address, and phone number. The contest begins on November 30, 2024, at 12:00 p.m. EST and ends on December 21, 2024, at 4:00 p.m. EST. Each contestant may enter the contest once during the contest period. By entering the contest, contestants agree that they have read and understood the Contest Rules herein.

Contestants must be present in the Sales Office to participate. They cannot enter the contest on behalf of a family member or relative who is not physically present in the Sales Office at the time of entry or doesn't meet eligibility requirements.

Prize

There are four (4) prizes to be awarded, each consisting of a gift basket valued at approximately \$200. Please note that one (1) gift basket will be awarded at each of Tamarack Homes' four (4) Sales Offices. The prize must be accepted as awarded.

No substitution of the prize is permitted by the contestants. Tamarack Homes reserves the right to substitute any item in the basket for another item of equal or greater value if an item cannot be awarded as described or is unavailable. Selection of Winners
